



# WELCOME TO FRANCE!

Temporary protection for **6 months**, renewable **up to 3 years**.

Registration at the prefecture of the host department to access the rights below.



## ADMINISTRATIVE RIGHTS



### TO ENTER FRANCE



**If you have a passport or visa (valid or expired within the last 2 years):**

you can go directly to the prefecture in France as soon as possible.



**If you do not have a passport:**

you can go to the French consular offices of the countries bordering Ukraine to obtain a visa or a laissez-passer. Once you have obtained your laissez-passer and entered France, you must go to the prefecture as soon as possible.



## DAILY LIFE



### HEALTH

**Health insurance:** free access to care. For more information, please contact your nearest Health Insurance office (*Caisse Primaire d'Assurance Maladie, CPAM*).



### CHILDREN'S SCHOOLING

Enrollment of children in school as soon as they arrive in France. In France, access to school is free for all and compulsory from 3 to 16 years old.



### To enroll your child in school:

- If they are between **3 and 10 years old**, the enrollment needs to be done at the City Hall of your place of residence;
- If your child is between **11 and 18 years old**, you can contact either the middle school or high school closest to your place of residence, or the National Education services in the department of your place of residence.
- For young people aged **16 to 18** who were not/would not like to go to school, the *Direction des services départementaux de l'éducation nationale* (DSDEN) will help you find a job or professional training.

## WORK

You are authorized to work in France as soon as you obtain your temporary residence permit, which is subjected to the rules of the chosen profession. If you are looking for a job, you can receive support from the public employment service. To do so, contact the nearest Prefecture, which will direct you to the appropriate service.



## LANGUAGE LEARNING

French classes are taught by volunteers

## TRANSPORTATION

As soon as you arrive in France, you can get free tickets to travel by train.

## BANKING

You are allowed to open a bank account. You can transfer funds from a bank account in Ukraine to a bank account in France or in the European Union.

## PHONE

Free operator offer free mobile packages for Ukrainian refugees.



## ACCOMODATION

Upon arrival, you will be welcomed in an emergency reception site for one or two nights.

Depending on your personal situation, the composition of your household, the capacities of the territory, and following the different assessments made by the social workers, you will be given an accommodation for a period of several weeks/months, before benefiting from permanent housing.

## FINANCIAL ASSISTANCE:

Table of the Allocation for the asylum seeker (ADA) according to the number of people in the household.

The amount of the claimant's allowance is determined on a daily basis. The following table shows the daily amount of ADA paid according to the number of people in the family.

The asylum seeker's allowance is paid by the Agence de services et de paiement (ASP), at the end of each month by «feeding a withdrawal card» or bank transfer.

If there is a change in the situation, the asylum seeker must report it to Ofii.



Depending on the availability, you may be housed in another city, another department or another region than your arrival city in France. Ask the emergency reception center or the Prefecture for information.

**Social workers will help you with the administrative procedures.**
